## Specialist places

### 1) Art and Design

- Children applying for specialist Art and Design places are required to attend the school on the designated selection day 28 November 2020 to undertake a series of Art and Design tasks.
- These tasks give them the opportunity to show their abilities in a range of media and with a range of resources.
- Students' work is then assessed by the Art Department.
- Written tasks give them the opportunity to analyse art work and evaluate their own work.
- Applicants scoring 40% and above are put in rank order, and places offered to the top 30.
- Applicants scoring 40% and not in the first 30 constitute the Art Specialist Waiting List.
- Applicants not scoring 40% are considered automatically under the criteria for a general place.

### 2) Modern Foreign Languages

- Applicants for Modern Foreign Languages places are required to attend the school on the designated selection day 28 November 2020 and are given a series of tests specifically designed to test their aptitude for languages.
- Applicants do NOT have to have studied a Foreign Language before; the test assesses aptitude through linguistic skills, such as oral and aural communication and memory.
- Students are assessed on their ability to recognise patterns in languages through four different tests. Two of these involve the students being taught a new language and then having to apply the rules that they have learnt to answer questions. The other two tests require students to show a good level of understanding of English vocabulary and to be able to spot patterns in another language to answer questions.
- Marks for each of the above stages are aggregated to form a final mark.
- Applicants scoring 40% and above are put in rank order, and places offered to the top 30.
- Applicants scoring 40% and not in the first 30 constitute the Languages Waiting List.
- Applicants not scoring 40% are considered under the criteria for a general place.

Parents whose child routinely receives extra time in timed written assessments must notify the school as soon as possible by emailing [admissions@chestnutgrove.wandsworth.sch.uk](mailto:admissions@chestnutgrove.wandsworth.sch.uk) to request the extra-time application form.
